### 1 Talent Privacy Policy

This Privacy Policy sets out how Company Advertising LTD T/A 1 Talent, uses and protects any information that you give to us when you use our services.

1 Talent is committed to ensuring that your privacy is protected. Should we ask you to provide certain information by which you can be identified when using our services, then you can be assured that it will only be used in accordance with this Privacy Policy.

## When we collect information from you

We may collect information from you if you enquire about our services, and/or we contact you believing that you are in need of our services and/or you are a client of 1 Talent and have an account with our company or when you otherwise correspond with us.

We may also collect information from you when you; use and/or register on our website, subscribe to our newsletter, fill out a form, use live chat and/or open a support ticket.

## What information we collect from you

We may collect the following information if you enquire about our services, and/or we contact you believing that you are in need of our services and/or you are a client of 1 Talent:

- Name and job title/company position
- Contact information including address, email address and phone number
- Information such as business trading demographics, business preferences and needs, business interests and relevant plans, and any other information to facilitate consultancy services
- Company Registration Number
- VAT Registration Number
- Third party contact details (You must gain authority from the third party to issue us with the third party's details and make the third party aware that we may contact them to discuss your needs and/or requirements).
- Standing Order and/or Direct Debit, Payment Card information, preferred payment information

### Why we collect this information

- We collect this information to ensure that we can contact you to discuss your requirements and liaise with you and/or a third party in relation to the services that we can provide and/or are providing you.
- To process payments in relation to your account.
- We may periodically send promotional communications in relation to new products, special
  offers or other information which we think you may find interesting using the contact details that
  you have provided.

## What we do with the information that we collect

- Manage your account and provide payment processing. All card payment data and bank details
  are processed by third party payment providers such as Square Up and the banks that standing
  orders and direct debits are set up with. We understand that these authorities are PCI-DSS
  regulated. No sensitive information is stored within our internal systems.
- Measure and improve our Services, keep our Services safe, secure and operational
- Communicate with you and/or an authorised third party in relation to your account
- To provide other services requested by you as described when we collect the information
- To prevent, detect, mitigate, and investigate fraud, security breaches or other potentially prohibited or illegal activities
- Contact you regarding your account, to troubleshoot any problems with your account and/or services, to resolve a dispute, to collect fees and/or monies owed on your account and/or as otherwise necessary to provide services in relation to your account
- Give authority to Company Advertising LTD and other Company Advertising LTD companies or trading names to have access to your personal information in accordance with the policy. These companies operate with similar privacy policies and are required to protect your personal information at least as strictly as we do.

When contacting you for such purposes as outlined above, we may contact you via email, telephone, SMS/text messages, postal mail and via mobile push notifications.

#### Who we share this information with

- There may be instances where we need to share your information with third parties. Examples of these third parties are:
- Our Accountants. This is to facilitate preparation of accounts in relation to HMRC criteria. This
  body will have access to information in relation to your account and are registered and regulated
  by the required authorities
- Debt collection agencies. This is to facilitate the collection of outstanding payments owed by our debtors
- The Courts. This is for any litigation purposes

#### **Customer Relationship Management System**

Our internal Customer Relationship Management System log all communications between potential and current clients to allow us to provide a better service and deal with enquiries and support tickets in an effective and prioritised manner. This system is used to store the information that we collect from you. We understand from our supplier that this system is GDPR Compliant.

#### **Recorded Telephone Calls**

We may record selected telephone calls for the purpose of, but not limited to, training, marketing, customer service and dispute resolution. These are recorded calls of the communication that has traversed the telephony network between us and potential and current clients. It typically includes a source, destination and duration although it can also include quality metrics and used for fraud prevention purposes. Our systems are utilised to store recorded call data. We understand from our supplier that this system is GDPR Compliant.

#### How long we retain your data for

Personal data is stored for no longer than necessary. How long we retain personal information can vary significantly based on context of the Services we provide and on our legal obligations. After it is no longer necessary for us to retain your personal information, we will dispose of it in a secure manner.

#### How do we protect your information?

Your privacy is of the utmost importance to us. Our Privacy Policy outlines limitations on the use of your contact information. We will not sell or rent your personal information to third parties for their marketing purposes and will only disclose your personal information in accordance with our Privacy Policy and/or with your explicit consent.

We disclose limited personal contact information in response to requests from the Police and other government agencies in relation to criminal investigations, alleged illegal activity or any other activity that may expose us, you or any other 1 Talent client to legal liability, in accordance with our Privacy Policy.

#### We use Cookies on our website

Cookies are small files that a site or its service provider transfers to your computer's hard drive through your Web browser (if you allow) that enables the site's or service provider's systems to recognize your browser and capture and remember certain information.

#### What we use cookies for

We use cookies to help us understand your preferences based on previous or current website activity, which enables us to provide you with improved services. We also use cookies to help us compile aggregate data about site traffic and site interaction so that we can offer better site experiences and tools in the future.

## Third-party disclosure

We will only speak to a third party in relation to your account, for example your previous website provider, on your authority. In the event that you wish for us to speak to a third party on your behalf and in relation to your account you must gain authority from the third party to issue us with the third party's details and make the third party aware that we may contact them to discuss your needs and/or requirements.
